Mr. Gerst moved to approve the temporary hire of Heather Martz as a Clerk/Typist for Children & Youth Services at an annual rate of \$15,600.00, effective July 9. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Ward recognized Laura Klodnicki on receiving the prestigious Girl Scout Gold Award. Laura, the daughter, of Kathy and Joseph Klodnicki of Liberty Township, established a soccer camp for girls at Meadowbrook Christian School, for her Gold Award Project.

Mr. Gerst encouraged the public to attend the Friends of Challenger Pig Roast and Auction to benefit the Danville Challenger Little League teams. The event is scheduled for Saturday, June 30, at Southside Fire Co., Riverside.

Mr. Ward announced the upcoming Local Leaders Listening Day, sponsored by Extension at the Ferry Street Growers Market, at 10 a.m. July 14. The day will provide local residents an opportunity to discuss issues with local legislators and elected officials.

Mr. Ward also noted that Applebee's restaurant near Bloomsburg will host a benefit breakfast for Columbia Montour Aging on Saturday, June 30.
