Mr. Ward moved to approve the minutes of the previous meeting. Mr. Gerst seconded. On called vote, all voted in favor.

Mr. Ward moved to approve an intent to participate in the update of the County Hazard Mitigation Plan with the Pennsylvania Emergency Management Agency. Mr. Gerst seconded. On called vote, all voted in favor.

Mr. Gerst moved to affirm the resignation of Renee L. Cooke, Domestic Relations Enforcement Officer, effective July 13. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Gerst announced the upcoming Local Leaders Listening Day, sponsored by Extension at the Ferry Street Growers Market, at 10 a.m. July 14. The day will provide local residents an opportunity to discuss issues with local legislators and elected officials.

Mr. Gerst moved to pay the following bills: General Account, \$75,352.73; Children & Youth, \$46,038.07; Transit, \$8,331.77; Liquid Fuels, \$14.27; Act 78, \$301.55; Domestic Relations, \$2,434.84; Human and Community Service, \$34.54. Mr. Ward seconded. On called vote, all voted in favor.
