Mr. Hartman moved to affirm the hiring of Bonita Hartzell as Deputy Treasurer effective January 2, at a salary of \$21,000.00. Mr. Finn seconded. On called vote, all voted in favor.

Mr. Finn moved to affirm the hiring of John Brent as a part-time Deputy Sheriff effective January 4 at a rate of \$12.33 per hour. Mr. Hartman seconded. On called vote, all voted in favor.

Mr. Hartman moved to affirm the appointment of Bradley Miller as Court Tipstaff effective January 3 at a \$100.00 per diem. Mr. Finn seconded. On called vote, all voted in favor.

Mr. Hartman moved to approve the transfer of part-time employee Glen Boggs from the Assessment Office to the Veterans Affairs Office, effective January 2. Mr. Finn seconded, noting that the transfer was made with the full approval of both the Assessment and Veterans Affairs offices. On called vote, all voted in favor.

Mr. Hartman moved to approve a Family Medical Leave Act request by Justin Ramiza, CYS Caseworker, effective January 22. Mr. Finn seconded. On called vote, all voted in favor.

Mr. Finn moved to approve the termination of Michael Davis, a probationary Correctional Officer, effective January 3. Mr. Hartman seconded. On called vote, all voted in favor.

Mr. Finn moved to pay the following bills: General Account, \$336,109.07; Children & Youth, \$22,906.21; Liquid Fuels, \$466.56; Uniform 911, \$12,462.49; Human and Community Service, \$2,426.49. Mr. Hartman seconded. On called vote, all voted in favor.
